You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of DIP fund. The Fund is an open-ended mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 4 years.

Objectives

The objective of this actively managed Sub-Fund is to optimize the risk/reward ratio with a capital preservation policy. The Sub-Fund will employ the absolute VaR method to calculate the global exposure, being 8% the maximum limit. The Sub-Fund's expected level of leverage is 50%. This level of leverage may vary over time, being higher under certain circumstances. The disclosed expected level of leverage, calculated by the sum of notionals, is not intended to be an additional exposure limit for the Sub-Fund.

The Sub-Fund mainly invests in units/shares of UCITS or UCIs invested in governmental and corporate bonds, stocks of companies and commodities.

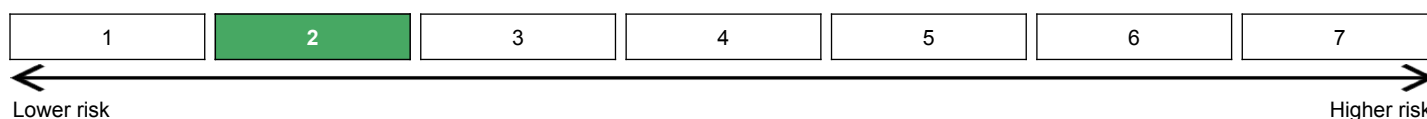
The Sub-Fund may also use financial derivative instruments and financial derivative indices dealt in on a Regulated Market either for hedging and investment purposes, at all times in compliance with the Grand Ducal Regulations. It also may enter into OTC forward currency agreements for hedging purposes and, to a lesser extent, for investment purposes.

Intended retail investor

The Sub-Fund is suitable for investors with a medium/high-risk tolerance and looking for an investment term of four years.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 4 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Other risks: Credit risk, Liquidity risk, Counterparty risk, Operational risk, Derivatives risk, Currency risk, Event Risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between November 2017 and November 2018 (If you exit after 1 year), July 2016 and July 2020 (If you exit after 4 years).

Moderate scenario: This type of scenario occurred for an investment between January 2016 and January 2017 (If you exit after 1 year), June 2017 and June 2021 (If you exit after 4 years).

Favourable scenario: This type of scenario occurred for an investment between October 2024 and October 2025 (If you exit after 1 year), September 2020 and September 2024 (If you exit after 4 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 2.7 % before costs and 1.3 % after costs.

Recommended holding period: 4 years

This fund has no minimum holding period, but has been created for medium term investment. You should therefore be prepared to remain invested with your investment for at least 4 years. However, you can return your investment on any bank business day in Luxembourg.

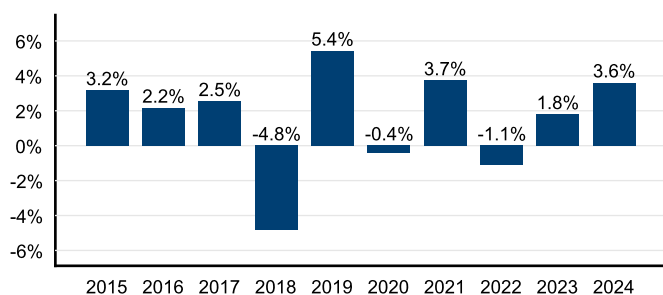
