WHAT IS THIS PRODUCT?

Type:	An open-ended investment company incorporated with limited liability
Term:	The Fund does not have a targeted closure date and may be liquidated at any time, as further detailed in the Prospectus
Objectives:	To provide a total return, including both capital growth and dividend income (after fees have been deducted), in excess of MSCI All Country World Index (ACWI) Net Total Return Index over a rolling five year period by investing in equity and equity related securities in the agricultural sector.

Investment Policy:

The Fund will seek to achieve its investment objective by investing at least 70% of its Net Asset Value directly and indirectly in equities and equity-related securities in any issuer, including those in developed and emerging markets, where the majority of earnings of issuers or holding issuers are derived from activities related to any commodities which are grown or raised, commonly known as agricultural or soft commodities. The Fund will invest at least 50% of the Fund's Net Asset Value in equities of issuers that exhibit positive or improving ESG characteristics. The remainder of the Fund may invest in shares outside of the agricultural sector, bonds (such as those issued by governments, sovereigns, supranationals and companies globally) and cash.

The Fund may use derivative instruments for both investment and hedging purposes. The return on a derivative is linked to movements in an underlying instrument referenced by the derivative such as currency or interest rates. The base currency of the Fund is GBP.

Share Class Currency Hedging: This Share Class is not hedged.

Distribution Policy: N/A - Income will be rolled up into the value of your investment.

Dealing Frequency: Daily. Investors can buy and sell their shares on demand on each Business Day (as defined in the Prospectus).

Benchmark: MSCI All Country World Index (ACWI) Net Total Return Index ("ACWI Index"). The Fund is actively managed and is not designed to track the benchmark therefore the Fund's performance may deviate materially from the benchmark. The investment manager has complete discretion in making investments and is not constrained by the benchmark. The Fund may invest significantly in instruments which are not included in the benchmark. The benchmark is used only for risk management and performance comparison purposes. The investment manager may consider, for example, issuer exposures, sector weights, country weights and tracking error in each case relative to the benchmark but does not use the benchmark as an investment limitation.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator

WHAT HAPPENS IF BARING FUND MANAGERS LIMITED IS UNABLE TO PAY OUT?

The assets of the Fund are segregated from those of Baring Fund Managers Limited. The Depositary is responsible for the safekeeping of the Fund's assets. To that effect, if Baring Fund Managers Limited defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk of the Fund suffering some loss in case of default of the Depositary. You may face a financial loss if your broker or the entity from whom you purchased the Fund was to default.

Costs over Time
